

# KNOW THE LAW!

West Virginia law requires citizens to properly dispose of solid waste, either by subscribing to solid waste collection service, or by the resident transporting, along with maintaining receipts of, his or her own solid waste to a solid waste facility. (WV 22C-4-10)

Theft of services is a crime. (WV 61-3-24d) Theft of services is when any person, firm or corporation obtains services of any such value from another under false pretense. (WV 61-3-53) Unauthorized use of dumpsters is also a crime. Both crimes are punishable with fines up to \$2,500 and one year confinement in jail.

It is illegal to do the following with solid waste: burn, bury, dump in or near stream or body of water, dump into a roadside dump, or create an open dump on your property. Criminal penalties range from fines of \$2,500 to \$25,000 per day of violation and/or incarceration for up to one year.

## **SLOW DOWN TO GET AROUND**

WV SENATE BILL 378 | AUGUST 2014

This law **REQUIRES** drivers to slow down to 15 mph when passing a stopped solid waste collection vehicle.

Traffic concerns are increasing in the Enviroco service areas, especially Rt 220, Rt 259 and South Fork Rd. Please **SLOW DOWN** when approaching and/or passing our vehicles.

# 2022 ANNUAL RESIDENTIAL LETTER

## COLLECTION ROUTES

Solid waste is required to be ready for collection at 6:00am on your scheduled collection day. Per WV PSC rules and regulations and to avoid injuries, Enviroco Inc. may refuse to collect solid waste from a residential customer if solid waste is not in a suitable waterproof container with a loaded weight of thirty (30) pounds or less. A suitable, waterproof “container” shall include plastic bags and garbage cans.

## INCLEMENT WEATHER POLICY

When roads are hazardous and the safety of our employees, as well as other drivers, is in jeopardy, solid waste collection may be delayed and/or postponed until the following week or until the road conditions improve.

Updated collection route information during inclement road conditions is updated on our website [www.envirocoinc.com](http://www.envirocoinc.com), on our Facebook page (Enviroco Inc), our telephone messaging system and announced on WELD radio stations.

## 911 ADDRESSING:

Posting of your physical 911 address near the placement of your solid waste either on dwelling and/or mailbox is helpful in routing efficiency.

## BILL PAY

Choose from one of our many payment options.



**MAIL:** Send your payment to the address printed on the back of remittance bill stub.



**BANK:** Make payment at one of the following banks: Capon Valley, Summit Community, Grant County, or Pendleton Community.



**ONLINE\*:** Use our Online Bill Pay feature at [www.envirocoinc.com](http://www.envirocoinc.com). Must agree to Terms & Conditions. Can also enroll in Auto Pay.



**OVER THE PHONE:** Payments are accepted during regular office hours.



**OUR OFFICE:** Payments are accepted during regular office hours for walk-in customers. Payment Drop Box available after hours.

\*Customer is responsible for sufficient funds availability and updating expiration dates and vital payment information.

Please allow at least 5-7 business days for Enviroco Inc. to receive and post your payments. **Overdue payments must be received in our office prior to termination dates.** All overdue payments posted after the 15th of each month will be subject to a \$5.00 late payment fee. Terminated accounts must pay entire account balance plus a \$5.00 restart fee.

## BULKY GOOD & TIRE COLLECTION

Per residential customer, one bulky good item per month and up to 4 tires per month no more than 16.5 radius off rim (annual limit of 8) are allowed at no extra charge. These items **MUST BE SCHEDULED** at least 5 days in advance of your scheduled day.

**Any customer having more than one bulky good item and/or 4 tires per month or an excluded item/large amounts MUST call for a special pick up quote.**

For items containing FREON, this hazardous material **MUST BE REMOVED** by a certified person/business **PRIOR** to collection.

*The following is required by WV PSC:*

“Your service includes monthly removal of oversized items including, but not limited to refrigerators, washing machines, clothes dryers, dishwashers, ovens, stoves, microwave ovens, and other appliances; televisions; home computers; air conditioners; bicycles, furniture; waste tires off the rim, having a radius of no more than 16.5 inches, from automobiles, from pickup trucks, from motorcycles, from all-terrain vehicles, and from farm tractors; and other items, not included in the above, that are at least three (3) feet in length, width, or height or at least fifty (50) pounds in weight. The following items are not included in bulky goods service and your solid waste collector may refuse to pick them up: (a) automotive components, parts, or frames that weigh at least two hundred (200) pounds each; (b) automotive parts, such as motors and transmissions, that have a high density; (c) hazardous waste; (d) items that can be easily divided and placed into bags, boxes, or other containers, less than three (3) feet high, long, or wide, that, with contents, weigh less than fifty (50) pounds each; and (e) construction and demolition debris generally. This service is designed to eliminate the illegal disposal of oversized items.” Bulky goods pick up in your neighborhood will occur each month.

This service is for Enviroco customers **ONLY**. Must show valid recycling receipt from Enviroco Inc. Receipts are printed on monthly statements. If you need a recycling receipt, valid receipt copies can be obtained simply by calling our office.

Violators subject themselves to litter laws and applicable fines.
